There are charts that can help officers and non-sworn personnel chart paths toward an Administration of Justice Certificate of Completion, an Associate in Science Degree, and or an Associate in Science for Transfer Degree from Skyline College.

The Course Offerings by Modality chart permits students to take their AJ courses in either modality (online or in person) in the spring and fall semesters for their convenience (as shown on the chart), which can be accomplished in four successive semesters. We also have (online only) two AJ courses in summer.

The 2-year and 3-year course sequence charts lay out guided paths toward the Associate in Science (AS) Degree and/or Associate in Science for Transfer (AS-T) Degree.

- Commission on Peace Officer Standards and Training - David Honda
 - AB 490 isn't clear w/ their guidelines and should have clarity by the end of the year.
 - SB 2 – Groups at POST are creating more positions. Part of the law goes into effect the first part of the year and the other part of the law goes into effect Jan of 2023. More information to come.
 - Dec 8 & 9th there will be a commission meeting to discuss Use of Force requiring officers to attend a 10-70 instructor course. If approved, will need a refresher every 4 years.
 - Cultural Diversity & Racial Profiling has an online course to be released in January. You will no longer need a facilitator/trainer. The video will cover all requirements. (2hrs every 5yrs)
 - Strategic Communications training. In the process of developing an online training – hoping to be available in the beginning of the year.
